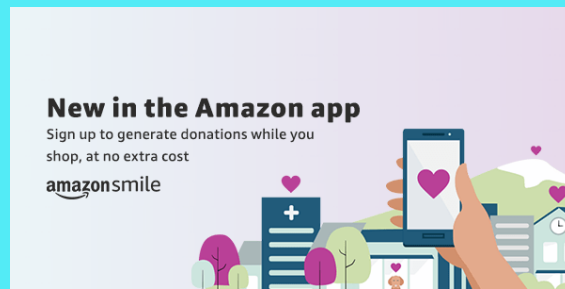

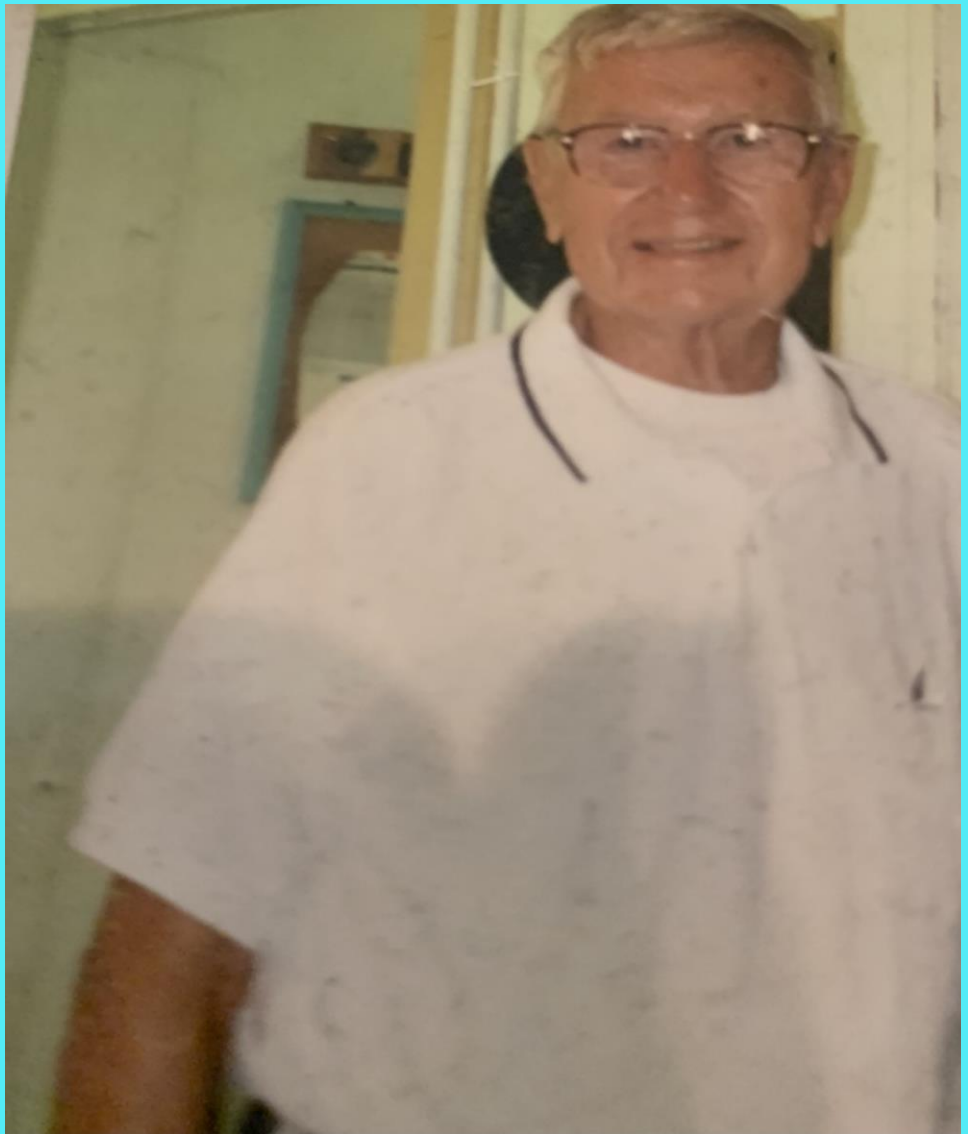

OUR NEW TRANSITION HOUSE... CARROLL HOUSE IS OPEN.

We have a new Transition House, named Carroll House. We have created a beautiful transition house which provides a lower level of care from Damascus House treatment. Carroll House is a unique place that not only is it a supportive and safe environment for those new to recovery to heal and rebuild their lives but also provides supports in form of employment support and case management. Carroll House who was named after long time Executive Director Carroll allows Damascus House, Inc. to continue and expand its mission of personalized recovery support. We call this a Transition House with supports. Carroll House is a traditional house, but we also provide case management and employment placement support for our residents at Carroll House. Our goal is to have all our residents at Carroll House succeed in their recovery.

All intakes will need to have a current negative COVID test (within 72 hours of admissions to Damascus House).
